


IOWA'S BOTTLE BILL

AN OUTDATED LAW IN 2005

Iowa's bottle deposit law, popularly known as the "Bottle Bill," passed in 1978 and includes all carbonated and alcoholic beverage containers. The Bottle Bill does not reflect the current beverage market.

NATIONAL TREND OF REDUCED RECYCLING



- The demand for PET (a plastic often used for soft drink bottles) has exceeded supply for years, yet fewer PET containers are recycled causing companies that recycle plastic to face hardship.

CONSUMPTION PATTERNS HAVE CHANGED

Since the Bottle Bill has passed a variety of new beverages, such as sports drinks and bottled water, have been introduced. These beverages were not included in the law as they did not exist in 1978.

COSTS HAVE GONE UP

- Value of a 1978 dollar today **\$2.94**e
- To keep pace with inflation the 5-cent deposit would be





To keep pace with inflation the 1-cent handling fee would be..... **nearly** $3c^e$
